POSITIONS UP FOR ELECTION

CSES Council (requires 1% of population's unique signatures)*

- SREE A Councillor* [min. 1 signature]
- SREE B Councillor* [min. 1 signature]
- First Year Representative** (x2) [min. 19 signatures]

*A councillor candidate can only solicit signatures from others within the same program. I.e. software from software, etc.

**First year representative councillors can only solicit signatures from other students in their first year of engineering. They do not have to be from students within the same program as the candidate.

ELECTION TIMELINE

- 1. Nomination Period: Tuesday, September 17th, 2019 @ 8:30 to Thursday, September 19th @17:30.
- 2. All Candidates Meeting: Friday, September 20th, 2019 @ 17:30 in ME 3390 (The CSES Office)
- 3. Campaigning Period: Saturday, September 28th, 2019 @ 0:00 to Friday, October 4th @17:30
- 4. Town Hall: Wednesday, October 2nd, 2019 @ 18:00 location TBA
- 5. Voting Period: Friday, October 4th, 2019 @ 18:00 to Sunday, October 6th @ 23:59 through Online Ballot

Or

Voting Period: Fall General Meeting, Tuesday, October 8th, 2019 @ 18:00 location TBA (in the event that Online Balloting is not possible)

LOCATIONS

- All election materials, including nomination forms and regulations, will be available in the CSES Office (ME 3390);
- Nominations are to be submitted to the CSES Office (ME 3390);

All voting will take place online via a link provided to all students through the CU Mail email system
if online is made possible.

RESTRICTIONS

- Students wishing to run for a Councillor position may only run for a seat that represents their own engineering program. Similarly, students may not nominate or vote for Councillor candidates in a program different from their own.
- The number of seats for a particular position represents the maximum number of candidates a student may nominate and/or vote for, for that position.
- Students may not nominate themselves for any position (i.e. sign their own nomination form).
- In order to be on CSES Council (i.e. to run as a candidate in the 2019 Fall Elections), all persons must:
 - Be Regular Members in good standing (as defined in the CSES Constitution);
 - o Be 18 years of age or older by October 9th, 2019;
 - Be individuals;
 - Not have been declared incapable by a court in Canada or in another country; and
 - Not be in bankrupt status

CHIEF ELECTORAL OFFICER & ELECTORAL COMMITTEE

The CEO for the Fall 2019 CSES Elections will be Cameron Lamont. The CEO can be contacted via ceo@cses.carleton.ca and will respond to all emails within 24 hours of receipt.

The Electoral Committee will be made up of Jordan Stumpf and Jeremiah Bell, with the CEO acting as chair. Each member of the electoral committee is entitled to one vote. They may be contacted via electoralcommittee@cses.carleton.ca.

CHANGE CLAUSE

The CSES Council recognizes that the dates of the Election Period may have to be moved back by 7 days based on OIRP's ability to create the elections lists. The CSES Council allows the Election Committee to change this date if they deem it necessary. The Elections Committee will give notice of any change that needs to happen as soon as the need becomes known.
