POSITIONS UP FOR ELECTION

- **Department of Electronics Representative**
- **Department of Civil and Environmental Engineering Representative**

A position on the CUESEF Board of Allocators requires 15 unique signatures

Candidates must solicit signatures only from others within the same department (i.e. Department of Mechanical and Aerospace Engineering representative from all streams under the Department of Mechanical and Aerospace Engineering, etc).

Each position consists of a two year term (May 1st 2020 - May 1st 2022).

ELECTION TIMELINE

The CUESEF Election Timeline will follow that of the timeline defined in the Carleton Student Engineering Society's (CSES) Writ of Election for the 2020 CSES General Elections. The timeline is as follows:

- Nomination Period: Monday, February 3rd, 2020 @ 8:30 to Friday, February 7th at 17:30.
- All-Candidates Meeting: Friday, February 7th @ 18:00 (ME 3390).
- Town Hall: Wednesday, February 26th @ 18:00 (location TBA).
- Campaigning Period: Monday, February 16th @ 8:30 to Tuesday, March 3rd @ 23:59.
- Voting Period: Wednesday, March 4th @ 0:00 to Sunday, March 8th @ 23:59.

LOCATIONS

- All election materials, including nomination forms and regulations, will be available in the CSES Office (ME 3390).
- Completed nomination forms must also be submitted to the CSES Office (ME 3390) before 17:30 on Friday, February 7th, 2020.
- All voting will place online via a link provided to all students through the CU email system.

RESTRICTIONS

- Students wishing to run for a department representative position may only run for a seat that represents their own engineering department. Similarly, students may not nominate nor vote for CUESEF board candidates that will not represent them
- The number of seats for a particular position represents the maximum number of candidates a student may nominate and/or vote for, for that position;
- Students may not nominate themselves for any position
- In order to be on the CUESEF Board of Allocators (i.e. to run as a candidate in the 2020 General Elections), all persons must be 18 years of age or older by May 1, 2020
- In order to be eligible for the position, you must be opted into the CUESEF funding option through Carleton Central

CHIEF ELECTORAL OFFICER AND ELECTORAL COMMITTEE

- CUESEF's elections shall be officially run in partnership with CSES. By default, the CEO and electoral committee of the CSES general elections shall also hold the same position under CUESEF
- The CEO for the 2020 CSES General Elections will be Cameron Lamont. The CEO can be contacted via ceo@cses.carleton.ca and will respond to all emails within 24 hours of receipt.
- The electoral committee for the 2020 CSES General Elections will be Jeremiah Bell, Jordan Stumpf, and the CEO as chair.

CHANGE CLAUSE

Both CUESEF and CSES recognizes that the dates of the Election Period may have to be moved back by 7 days based on OIRP's ability to create the elections lists. The CUESEF Board of Allocators allows the Elections Committee to change this date if they deem it necessary. The Elections Committee will give notice of any change that needs to happen as soon as the need becomes known.
